Proposed Action Title: Oregon State University - Converting Biogas to Liquid Fuels by Low Energy Electrical Corona Discharge Processes

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Corvallis, OR

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop a process that converts methane to higher chain hydrocarbons when passed through a corona discharge at close to ambient temperature. Specifically, the project team will: (1) develop and test a bench scale microstructured flow through reactor and research platform to support the operation of the reactor; and (2) develop and refine computational fluid dynamic and reaction model to reflect the demonstration reactor to yield a model useful for future commercialization. If successful, the process could enable the selective conversion of biogas into high value products with energy expenditure similar to that required for thermal processes.

Project tasks will be conducted on a small-scale basis in dedicated laboratory, testing, and fabrication facilities at Oregon State University (Corvallis, OR). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
