Proposed Action Description:

AMENDED NEPA DETERMINATION (See attached original Determination, dated February 16, 2016)

This Amended Determination follows the approval of additional funds and project milestones. Additional funding will support the project team's small-scale, research and development activities to engineer, characterize, and test performance of an improved catalyst and other system components for an ammonia synthesis reactor. If successful, the project will verify that small-scale ammonia energy storage, where the ammonia is synthesized from air, water, and renewable energy, can be commercially viable.

Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion(s) identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Proposed Action Title: Starfire Energy - NH3 Synthesis for Fuel, Energy Storage, and Agriculture Applications

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Aurora, CO; Golden, CO

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop a modular, small-scale Haber-Bosch (HB) type process for ammonia synthesis that is less energy-intensive and more economical than conventional, large-scale HB. Specifically, the project team will: (1) conduct electric synthesis and catalyzation; (2) conduct electric bench-top testing; and (3) model and develop a small-scale prototype reactor. If successful, small-scale HB reactors could enable distributed ammonia production as a zero-carbon fuel, for energy storage and agriculture and to be more compatible with energy inputs from intermittent distributed energy resources.

Project activities will be conducted at existing facilities that are designed for the applicable activities, and will be conducted in accordance with applicable Federal, State, and local safety and environmental requirements.


