Proposed Action Title: Colorado State University -- Paintable Heat-Reflective Coatings for Low-Cost Energy Efficient Windows

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Berkeley Hills, California; Pasadena, California; Fort Collins, Colorado

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a paintable coating to inexpensively retrofit energy-inefficient windows with a heat-reflective, visibly transparent film. Specifically, the project team will (1) formulate paint and optimize the coating chemistry; (2) evaluate best candidate solvents and glass treatment procedures; and (3) demonstrate prototypes of infrared-reflecting film on rough glass surfaces. If successful, widespread implementation could reduce the national consumption of electricity for cooling by 35 billion kWh, saving \$4 billion per year. The proposed film would improve cooling savings by 25%, at 10% of the cost. (\$1.50 installed sq/ft. vs. \$15.00 installed sq/ft. state-of-the-art). This improved energy efficiency would also decrease CO2 emissions by over 26 million tons per year.

Project activities will be conducted at existing facilities at Colorado State University (Fort Collins, CO), California Institute of Technology (Pasadena, CA), Lawrence Berkeley National Laboratory (Berkeley Hills, CA), and Materia, Inc. (Pasadena, CA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
