Proposed Action Title: Fervo Energy Company -- SOLVE EGS: Surface OrbitaL Vibrator for Evaluation of Enhanced Geothermal Systems

Program or Field Office: Advanced Research Projects Agency - Energy

## Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a Surface Orbital Vibrator Distributed Acoustic Sensing (SOV-DAS) fiber optics-based tool to enable down-hole characterization of the most critical aspects of an enhanced geothermal system (EGS). Specifically, the project team will (1) perform numerical modeling to characterize the anticipated range of seismic signal attenuation and the associated signal detectable by the DAS array; (2) conduct site selection and engineering design for a full-scale field demonstration of the SOV-DAS tool; and (3) install system and perform a multistage, multicluster hydraulic stimulation treatment in an existing geothermal well and conduct repeated SOV-DAS surveys to validate the system's efficacy. If successful, the innovative SOV-DAS system will provide unprecedented resolution on fracture processes critical for EGS reservoir creation, maintenance, and operation.

Project activities will be conducted at existing facilities at Fervo Energy, Co. (Berkeley, CA) and Rice University (Houston, TX) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work. Prime Recipient, Fervo Energy Co., under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing applicable project work (including, but not limited to, field demonstrations at geothermal energy facilities) before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same.)

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
