Proposed Action Title: HyperJet Fusion Corporation -- Plasma Guns for Magnetized Fuel Targets for PJMIF

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Chantilly, VA

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop and characterize a new magnetized plasma gun. Specifically, the project team will (1) develop computational modeling of plasma gun performance; (2) design, fabricate, and install an appropriate bias field coil on the remounted gun; (3) upgrade and operate diagnostics; and (4) perform experimental campaigns. If successful, the project team will demonstrate a new, high-density, high-velocity plasma gun for use in a broad variety of fusion energy architectures, with potential uses including refueling and targeted injection / control of fusion plasmas.

Project activities will be conducted at an existing facility at HyperJet Fusion Corporation (Chantilly, VA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
