Proposed Action Title: Idaho National Laboratory -- NEXT-GENERATION METAL FUEL

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Sunnyvale, CA; Idaho Falls, Idaho; Corvallis, OR

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to fabricate a metallic fuel that is essentially pre-swelled, and in contact with the cladding, thus removing the need for a sodium (Na) bond. Specifically, the project team will (1) incorporate porosity into the fuel using advanced manufacturing, (2) develop and test cladding material, and (3) conduct out-of-pile furnace testing and computer modeling to ensure the pore structure can withstand reactor temperatures as well as higher temperatures present in an off-normal event. If successful, the project team will develop a porous fuel design that eliminates the need for a sodium bond and has enhanced fuel-cladding chemical interaction (FCCI) resistance. Therefore, the operating temperature of the reactor can be increased, which will lead to higher power output.

Project activities will be conducted at existing facilities at Idaho National Laboratory (Idaho Falls, ID), Oregon State University (Corvallis, OR), and Oklo, Inc. (Sunnyvale, CA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.


