Proposed Action Title: Johns Hopkins University -- Electrothermal Conversion of Methane into Hydrogen and High-Value Carbon Fibers

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): San Diego, CA; Baltimore, MD; College Park, MD; Atlanta, GA

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a scalable approach toward energy-efficient conversion of low-quality carbon (LQC) derived from methane pyrolysis into valuable graphitized carbon fibers (GCFs). Specifically, the project team will (1) develop a novel electrothermal reactor to pyrolyze methane into hydrogen and low-quality carbon products and (2) integrate innovations of LQC fiber spinning and direct Joule heating of carbon fiber upgrading. If successful, the project team will demonstrate a manufacturing process that is cost-effective, scalable, and built to accommodate various feedstocks and intermittent renewable energy sources.

Project activities will be conducted at existing facilities at Johns Hopkins University (Baltimore, MD), University of Maryland (College Park, MD), Georgia Institute of Technology (Atlanta, GA) and the University of California, San Diego (San Diego, CA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
