Proposed Action Title: Los Alamos National Laboratory -- Portable Soft X-ray Diagnostics for Transformative Fusion-Energy Concepts

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Los Alamos, NM; Reno, NV; Seattle, WA

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to field three types of portable soft x-ray diagnostics at several ARPA-E-funded fusion research facilities. Specifically, the project team will (1) design custom port interfaces for each facility and diagnostic, including vacuum, electrical, electronic, and data acquisition connections; (2) identify and procure necessary components; and (3) calibrate and demonstrate the instrument. If successful, the project team's Soft X-ray imaging diagnostic will extend the present visible imaging capabilities already present at most of the field-testing facilities, allowing them to capture higher energy and higher temperature plasma regions. The team's techniques will also demonstrate the capability to estimate central electron temperatures in a quantitative and time-resolved way.

Project activities will be conducted at existing facilities at Los Alamos National Laboratory (Los Alamos, NM) and University of Nevada, Reno (Reno, NV) designed for the applicable activities, including field testing at the University of Washington (Seattle, WA). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work. Prime Recipient, under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing applicable project work at locations not listed above before (1) providing ARPA-E with required information; (2) obtaining all necessary permits and approvals; and (3) providing written assurances to ARPA-E of the same.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
