Proposed Action Title: North Carolina State University -- A Data-driven Approach to High Precision Construction and Reduced Overnight Cost and Schedule

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Idaho Falls, ID; Raleigh, NC

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a virtual environment platform that can support modular construction of nuclear power plants. Specifically, the project team will develop (1) a virtual environment platform that can model and simulate construction performance using as-planned Building Information Modeling (BIM) and as-built point clouds of off-site components and main structure, (2) a virtual assembly based on geometry, construction sequence, and logic, (3) automated data collection solutions for capturing as-built conditions of pre-fabricated components at off-site facilities using robotics and visual sensors, and 4) employment of risk-informed NQA-1 (Nuclear Quality Assurance-1) standards and proposed technology to evaluate systems and components that can be fabricated more efficiently with greater tolerances. If successful, the project team will build a software suite that can reduce the cost and schedule uncertainty of nuclear construction projects by leveraging virtual reality, automated inspection, and work flow optimization.

Project activities will be conducted at existing facilities at North Carolina State University (Raleigh, NC) and Idaho National Laboratory (Idaho Falls, ID) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
