Proposed Action Title: University of California, Santa Barbara -- Intelligent Reduction of Energy through Photonic Integration for Datacenters (INTREPID)

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop and demonstrate large, highly efficient switches capable of providing higher bandwidth and efficiency in datacenters of all scales. Specifically, the project team will (1) conduct a baseline architecture study; (2) design, assemble, and test first and second generation electronics; and (3) conduct laboratory demonstrations of functional coherent links achieving program metrics. If successful, the project team could achieve >2X improvement in transactions/joule at the datacenter level and 10-100X reduction in link power compared to current coherent technologies (<9pJ/bit datacenter-scale interconnects).

Project activities will be conducted at existing facilities at the University of California, Santa Barbara (Santa Barbara, CA); Intel Federal LLC (Santa Clara, CA); and Intel Corporation (Rio Rancho, NM) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
