Proposed Action Title: University of California at San Diego – LEED: A Lightwave Energy-Efficient Datacenter

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): San Diego, CA; Albuquerque, NM

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a unique energy-efficient and scalable optical circuit-switched architecture. Specifically, the project team will (1) evaluate single and multimode designs; (2) down-select, build, and characterize a design in a testbed; and (3) develop and demonstrate integrated photonic transmitter and receiver chips. If successful, the project team will demonstrate a scalable testbed-validated network, capable of significantly improving the energy-efficiency and performance of datacenters and high-productivity-computing (HPC).

Project activities will be conducted at existing facilities at University of California at San Diego (San Diego, CA); Sandia National Laboratories (Albuquerque, NM); Axalume Inc. (San Diego, CA); and inFocus Networks (San Diego, CA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

- There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
