Proposed Action Title: Ultrasonic Technology Solutions -- Extremely Fast and Efficient Direct Contact Ultrasonic Drying for Roll-to-Roll Manufacturing

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop direct contact ultrasonic dryer modules that can be retrofitted in a roll-to-roll manufacturing drying process. Specifically, the project team will (1) identify appropriate conveyor system and parts for prototype fabrication; (2) assemble and test bench-top continuous prototype for textile; and (3) design and fabricate larger, modular prototype, test performance, and refine system. If successful, the direct contact ultrasonic dryer compatible with the roll-to-roll manufacturing could have significant applications in textile, pulp and paper, chemical, carbon fiber and food and dehydration industries. By separating water mechanically without evaporation (a phase change process), the technology could demonstrate 5X higher efficiency and 2-3X faster-drying rate compared to thermal drying on typical textile fabric as well as paper samples.

Project activities will be conducted at an existing facility at Ultrasonic Technology Solutions (Knoxville, TN) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.


To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
