Proposed Action Title: University of Minnesota, Twin Cities - Enabling the Grid of the Future

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Minneapolis, MN; Golden, CO; Champaign, IL; Knoxville, TN; South Burlington, VT

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop a flexible, plug-and-play architecture wherein devices and small power networks can easily engage or disengage from other power networks or the grid. Specifically, the project team will: (1) develop and validate low power, medium power, and high power local inverter system (pLIS) units; (2) develop algorithms for coordination of multiple system units; (3) test low, medium, and high power pLIS units and the control, scheduling, and coordination algorithms. The hardware testing will use electric sources (e.g., photovoltaic arrays, power supplies, batteries) and loads (e.g., resistive loads, household appliances) in dedicated laboratory and commercial manufacturing facilities. If successful, the proposed system will enable coordinated response of many local units to adjust consumption and generation of energy, satisfy physical constraints, and provide ancillary services requested by a grid operator.

Project tasks will be conducted in dedicated laboratory, testing, and commercial manufacturing facilities at University of Minnesota, Twin Cities (Minneapolis, MN); National Renewable Energy Laboratory (Golden, CO); University of Illinois, Urbana-Champaign (Champaign, IL); University of Tennessee, Knoxville (Knoxville, TN); and Dynapower (South Burlington, VT). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
