Proposed Action Title: UHV Technologies, Inc. - Low Cost High Throughput In-Line XRF Scrap Metal Sorter

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Fort Worth, TX; Fort Wayne, IN

Proposed Action Description:

Funding will support the continued development of a high-grade, aluminum magnesium alloy scrap sorter that is low cost and automated. If successful, the aluminum scrap sorter will be deployed on a commercial scale and sort multiple tons of aluminum per hour for substantially less than the current cost per kilogram. Project tasks involve small-scale and pilot-scale research and development activities at UHV Technologies, Inc.'s laboratory facility in Fort Worth, TX and OmniSource, Corp.'s scrap yard in Fort Wayne, IN. Project work will be performed by trained personnel and comply with applicable federal, state, and local requirements.

Proposed Action Description:

UHV Technologies, Inc., in conjunction with Phinix, LLC, proposes to conduct small-scale, laboratory based, research, development, and demonstration of in-line (IL) x-ray fluorescence (XRF) spectroscopy to identify and separate high-grade aluminum and magnesium alloys from low-grade scrap materials. The proposed project aims to demonstrate the application of IL-XRF to commercial scale aluminum scrap sorting, enabling increased domestic recycling and reduce landfilling and exporting of the light metal materials.
