Proposed Action Title: INFINIUM, Inc. - Clean, Efficient Aluminum Electrolysis via SOM Anodes

Proposed Action Description:

Infinium, in conjunction with Boston University, was competitively selected to receive a seedling award under ARPA-E Funding Opportunity Announcement DE-FOA-0000882, Modern Electro/Thermochemical Advances in Light-Metal-Systems (METALS). The Project Team now proposes a follow-on effort to conduct laboratory based, small-scale, research and development activities that build upon work carried out by Infinium during its seedling project. Specifically, the follow-on effort will facilitate Infinium's development of an aluminum refining technique to dramatically reduce greenhouse gas emissions, energy consumption, and use of toxic materials in aluminum extraction.

No significant modifications will be made to existing facilities to accommodate the proposed work.

Proposed Action Description:

INFINIUM, Inc., in conjunction with Boston University, propose to conduct small-scale, in-lab, research, development, and testing to demonstrate a platform technology for producing metals from oxides using molten salt electrolysis, and adapt the technology to aluminum production. The proposed activities aim to reduce the energy input requirements and emissions and reducing the cost of aluminum production.
