Proposed Action Title: Arizona State University - Diamond Power Transistors Enabled by Phosphorus Doped Diamond

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Tempe, AZ; Davis, CA

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop thick, high quality epitaxial grown Phosphorus-doped diamond to enable development of diamond power transistors. Specifically, the project team will: (1) prepare doped diamond epitaxial films, junctions, low resistivity electrical contacts to doped diamond, and associated structures; (2) electrically characterize P-doped films and fabricate and characterize a device; (3) simulate electrical characteristics and transport of the doped diamond and its impact on power switching devices based on diamond materials. If successful, the project will be a viable wide bandgap competitor for power devices. No modifications will be made to existing facilities to accommodate the proposed work.

Project activities will be conducted at existing facilities that are designed for the applicable activities at Arizona State University (Tempe, AZ) and University of California, Davis (Davis, CA). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.
