Proposed Action Title: University of Utah - Electromagnetic Sorting of Light Metals and Alloys

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Salt Lake City, UT; Erie, PA; Plymouth, UT

Proposed Action Description:

Funding will support the development of a prototype industrial device to sort scrap metals in an automated fashion using an electromagnetic field. If successful, the technology will result in accurate, efficient, and inexpensive metal scrap sorting. Project tasks involve small-scale research and development activities in Salt Lake City, UT; Erie, PA; and Plymouth, UT. All project activities will comply with applicable federal, state, and local requirements. No modifications will be made to existing facilities to accommodate the proposed work.

Proposed Action Description:

The University of Utah proposes to conduct small-scale, laboratory-based, research and development activities for a prototype Variable Frequency Eddy Current Sorter (VF ECS) capable of precise and rapid identification of high-grade alloy materials, such as aluminum and magnesium. The proposed activities aim to demonstrate the potential of the VF ECS to reduce the energy demands and processing costs of sorting and recycling metal/alloy waste streams.
